SUMMARY

This document outlines the procedures for selecting participants in the Junior Class Olympic Rifle events for 2026 International competitions. See Appendix A for a calendar of the 2026 ISSF Junior competitions.

Selection Procedures for Open Class Olympic, Paralympic, non-Olympic, and non-Paralympic events are found in separate documents.

1. ELIGIBILITY REQUIREMENTS

Athletes must fulfill the following requirements to be eligible to compete in the 2026 Junior international events covered by these Selection Procedures.

- Be a USA citizen with a valid passport.
- Be a USA Shooting member in good standing.
- Abide by the eligibility requirements of the International Shooting Sports Federation (ISSF), the United States Olympic and Paralympic Committee (USOPC), the US Center for SafeSport, the United States Anti-Doping Agency (USADA), and the World Anti-Doping Agency (WADA).
- Satisfy the definition of Junior as described in ISSF Rule 3.7.4.12: Athletes will remain as Juniors until the 31st December of the year in which they become 21 years of age.
- Must comply with the new 2026 ISSF Equipment Rules to qualify to compete in international competitions.

2. SELECTION FOR THE 2026 ISSF JUNIOR WORLD CUP: CAIRO, EGY

UPDATE: USA SHOOTING HAS WITHDRAWN THE DELEGATION FROM THIS COMPETITION

Quick view: Selections for this competition are from the Final 2025 Ranking List.

2.1. Ranking for the Junior World Cup Cairo Selection

- 2.1.1. Nominations to compete in Junior World Cup Cairo will be based on the Final 2025 Ranking List (*Appendix B*).
- 2.1.2. The 2025 Final Ranking List is based on 2025 Selection Procedures.
- 2.1.3. Only National Team and National Development Team Junior members on the Final 2025 Ranking List will be eligible for nominations.

2.2. Individual Events

- 2.2.1. Nominations will be extended in each individual event in order of ranking until all Junior World Cup positions are filled or until all 2025 Ranking List National Team and National Development Team Junior members have received a nomination, whichever comes first.
- 2.2.2. Nominations must be accepted no later than March 1, 2026. In the event an athlete accepts a nomination after the acceptance deadline and that entry can still be accepted by the competition's Organizing Committee, that athlete will not displace an athlete entered in an in-competition slot even if ranked higher in the Selection.

2.3. Mixed Team Events

- 2.3.1. Mixed Teams will be comprised of athletes competing in the Individual Air Pistol events.
- 2.3.2. **Air Pistol Mixed Team USA 1** will be comprised of the highest ranked Junior Male and highest ranked Junior Female from the Junior World Cup Cairo Selection who are participating in the Individual Air Pistol events and who accept the Mixed Team USA 1 nomination.
- 2.3.3. **Air Pistol Mixed Team USA 2** will be comprised of the second highest ranked Junior Male and second highest ranked Junior Female from the Junior World Cup Cairo Selection who are participating in the Individual Air Pistol events and who accept the Mixed Team USA 2 nomination.
- 2.3.4. Athletes may decline a nomination to a Mixed Team and be replaced by the next ranked athlete no later than noon two days prior to the start of the Mixed Team event (ISSF Rule 6.18.1.4).

3. SELECTION FOR THE 2026 ISSF JUNIOR WORLD CHAMPIONSHIPS: SUHL, GER

Quick view: There are two pathways onto the Junior World Championship Team, the International Results Pathway and the Junior Olympics Pathway.

3.1. 2026 Junior World Championship Entries (ISSF Rule 3.7.5)

- 3.1.1. The maximum number of individual entries is six (6) entries per event. All six (6) entries are in-competition (medal contending), but no more than three (3) athletes from one country can qualify for the Final.
- 3.1.2. The maximum number of Mixed Team entries allowed is two (2).
- 3.1.3. The maximum number of Team entries allowed is one (1). These are typically 3-Member Teams.

3.2. Selection Pathway 1: International Results Pathway

- 3.2.1. Athletes who have medaled in individual events in the following competitions will receive a nomination to the 2026 ISSF Junior World Championships in the event in which they medaled:
 - Medaled in any previous ISSF Junior World Championship.
 - Medaled in any previous open ISSF World Championship.
 - Medaled in an open ISSF World Cup within 9 months of (and before entries are submitted for) the 2026 ISSF Junior World Championships.
- 3.2.2. Only individual medals will be considered; Team medals, including Mixed Team medals, will not count toward qualification.

3.3. Selection Pathway 2: USA Shooting Junior Olympics Pathway

- 3.3.1. All 2026 ISSF Junior World Championship slots not filled through Selection Pathway 1 will be filled through Selection Pathway 2, with nominations based on the results of the 2026 USA Shooting Junior Olympics, held in Anniston and Talladega, AL.
- 3.3.2. The ranking used for Selection Pathway 2 will be from the total aggregate of the two (2) ISSF qualification courses of fire and one (1) Final at the 2026 USA Shooting Junior Olympics.
 - 3.3.2.1. Athletes will qualify for the Final at the 2026 USA Shooting Junior Olympics based on the aggregate of the two (2) qualification courses of fire at the 2026 USA Junior Olympics.
 - 3.3.2.2. Athletes will carry their aggregate qualification score into the Final (the Final will not start from zero). The score from each Finals shot will be added to the aggregate qualification score. Eliminations will occur after the same number of shots as in an ISSF Final but will be based on the total of the aggregate qualification score and all Finals shots up to that elimination point. *See Appendix C for an example of how the combined qualification and Finals scores will be used for eliminations.*

3.4. JWCH Ranking for Selection to the 2026 ISSF Junior World Championships

- 3.4.1. The JWCH Ranking for Selection to the 2026 ISSF Junior World Championships will include all athletes who qualify through Selection Pathway 1 and all Finalists (athletes ranked 1st through 8th place) from Selection Pathway 2.
- 3.4.2. Athletes qualifying through Selection Pathway 1 (International Results Pathway) will be ranked the highest on the JWCH Ranking. If more than one athlete qualifies in an event through Selection Pathway 1, those athletes will be ranked according to their medal results in the following order of competition priority: (1) an open ISSF World Championship, then (2) an open ISSF World Cup, then (3) an ISSF Junior World Championship. Athletes will be ordered first by medals earned at the highest-tier competition, then the next tiers in order if necessary.

- 3.4.3. Athletes qualifying through Selection Pathway 2 (USA Shooting Junior Olympics Pathway) will be ranked on the JWCH Ranking after the Selection Pathway 1 athletes and in order of the ranked results from the 2026 USA Shooting Junior Olympics.

3.5. Individual Events

- 3.5.1. Nominations will be extended in each individual event in order of the JWCH Ranking until all World Championship positions are filled or until all athletes on the JWCH Ranking have been offered a nomination, whichever comes first.
- 3.5.2. Nominations must be accepted no later than 7 days after the conclusion of the 2026 USA Shooting Junior Olympics. In the event an athlete accepts a nomination after the acceptance deadline and that entry can still be accepted by the competition's Organizing Committee, that athlete will not displace an athlete entered in an in-competition slot even if ranked higher in the Selection.

3.6. Mixed Team Events

- 3.6.1. Mixed Teams will be comprised of athletes competing in the Individual Air Pistol events.
- 3.6.2. **Air Pistol Mixed Team USA 1** will be comprised of the highest ranked Male and highest ranked Female from the JWCH Ranking who are participating in the Individual Air Pistol events and who accept the Mixed Team USA 1 nomination.
- 3.6.3. **Air Pistol Mixed Team USA 2** will be comprised of the second highest ranked Male and second highest ranked Female from the JWCH Ranking who are participating in the Individual Air Pistol events and who accept the Mixed Team USA 2 nomination.
- 3.6.4. Athletes may decline a nomination to a Mixed Team and be replaced by the next ranked athlete no later than noon two days prior to the start of the Mixed Team event (ISSF Rule 6.18.1.4).

3.7. Team Events

- 3.7.1. Team Events (typically Three-Member Teams) will be filled by athletes who have qualified for the individual events and are in attendance at the competition. There will be no separate Team-only slots available.
- 3.7.2. Teams will be comprised of the three highest ranked athletes from the JWCH Ranking who are participating in the corresponding individual event.
- 3.7.3. If there are not enough athletes available from the corresponding individual event, athletes competing in other individual events can be nominated for a Team Event slot, provided they were a Finalist (athletes ranked 1st through 8th place) in the corresponding individual event at the

Selection. Nominations will be offered in the order of the JWCH Ranking in that corresponding event.

4. SELECTION FOR OTHER INTERNATIONAL JUNIOR COMPETITIONS REQUIRING ENTRIES THROUGH USA SHOOTING

4.1. Ranking for Selection

- 4.1.1. The Selection criteria used for nominations to compete in non-ISSF international Junior competitions that require entries submitted through a country's federation will depend on the timeframe of the international competition.
- 4.1.2. **January 1 to May 15, 2026.** Initial nominations for individual and team slots in international competitions starting between January 1 and May 15, 2026, will be based on the Final 2025 Ranking List. Nominations will be given in order of ranking from the Final 2025 Ranking List until all available slots are filled or until all National Team and National Development Team Junior members on the 2025 Final Ranking List have been offered a nomination, whichever comes first. Any remaining open slots will revert to development slots or remain unfilled. Development slots may be filled by Juniors on the current National Futures Team at the National Pistol Manager's discretion upon approval of the USA Shooting Selection Committee.
- 4.1.3. **May 16 to December 31, 2026.** Initial nominations for individual and team slots in international competitions starting between May 16 and December 31, 2026, will be based on the JWCH Ranking used for the 2026 Junior World Championships. Nominations will be given in order of ranking until all slots are filled or until all athletes on the JWCH Ranking have been offered a nomination, whichever comes first. Any remaining open slots will revert to development slots or remain unfilled. Development slots may be filled by Juniors on the current National Team, National Development Team, and National Futures Team at the National Pistol Manager's discretion upon approval of the USA Shooting Selection Committee.

4.2. Nomination Acceptance Deadline

Nominations must be accepted no later than 7 days before the competition entry deadline listed by the competition organizing committee.

5. SELECTION FOR OTHER INTERNATIONAL JUNIOR COMPETITIONS NOT REQUIRING ENTRIES THROUGH USA SHOOTING

5.1. Ranking for Selection

- 5.1.1. Athletes may enter any international Junior competition that does not require entries submitted through a country's federation by requesting a sanction from USA Shooting. The sanctioning request must include how athletes are selected for the competition and how the participating athletes' health and well-being will be ensured (for example, by demonstrating that SafeSport protocols will be followed).
- 5.1.2. USA Shooting may enter athletes as a delegation in any Junior international competition that does not require entries submitted through a country's federation. These are considered development slots and may be filled by Juniors on the current National Team, National Development Team, and National Futures Team at the National Pistol Manager's discretion upon approval of the USA Shooting Selection Committee.

6. SUBSTITUTIONS

6.1. Substitutions for ISSF Competitions and Non-ISSF International Competitions

- 6.1.1. **ISSF Competitions:** If an athlete vacates a slot for any reason, the next ranked eligible athlete will be substituted into that slot in the order of Selection ranking as long as the substitution can be made within the ISSF's and Competition Organizing Committee's entry deadlines.
- 6.1.2. **Non-ISSF International Competitions:** If an athlete vacates a slot for any reason, the slot may be filled by current National Team, National Development Team, and National Futures Team members at the National Pistol Manager's discretion upon approval of the USA Shooting Selection Committee.
- 6.1.3. If the substitution occurs at the competition, substitutions will come from the athletes already in attendance at the competition. Substitutions will be offered in order of Selection ranking.
- 6.1.4. Reasons for vacating a slot include but are not limited to declining the nomination, withdrawing from the competition, being removed from the competition by USA Shooting for a Code of Conduct violation, and being removed from the competition or deemed ineligible to compete by the ISSF or the Competition Organizing Committee.

7. FUNDING FOR INTERNATIONAL COMPETITIONS

7.1. Funding Criteria

- 7.1.1. USA Shooting makes every effort to fund athletes competing in-competition at major international competitions. However, qualifying for a team or a competition does not guarantee funding. USA Shooting may fully fund, partially fund, or not fund an athlete to a competition.
- 7.1.2. All funding decisions for Junior international competitions will be based on competition priorities and on Selection rankings.
- 7.1.3. Athletes qualifying for a team or a competition may elect to self-fund their participation. The self-funding process is described in the USA Shooting Self-Funding Policies and Procedures.

8. PERFORMANCE STANDARD SCORES

Performance Standard Scores will not be required to be qualify to compete in the Junior ISSF competitions or other Junior international competitions.

9. FORCE MAJEURE CONTINGENCY

9.1. Force Majeure Contingency for USA Shooting Selection Matches

In the event that USA Shooting is unable to conduct a Selection Match as planned due to extraordinary circumstances beyond the control of USA Shooting (such as natural disasters), USA Shooting may alter the selection procedures upon approval by the USA Shooting Selection Committee, to include reducing courses of fire required for selection.

9.2. Force Majeure Contingency for ISSF Competitions and Other Non-ISSF International Competitions

USA Shooting reserves the right to cancel participation in any ISSF competitions or other non-ISSF international competitions to protect the safety and welfare of the athletes and staff. USA Shooting will make these decisions based on the guidance from the US Olympic and Paralympic Committee and the US State Department. A USA Shooting cancelation applies to the entire delegation.

APPENDIX C: USA SHOOTING FINALS ELIMINATION EXAMPLE

Air Pistol

In this example, the following 8 athletes qualified for the Final by having the highest aggregate qualification scores:

Athlete A shot a 594 and a 595 = 1189
Athlete B shot a 594 and a 594 = 1188
Athlete C shot a 593 and a 592 = 1185
Athlete D shot a 593 and a 591 = 1184
Athlete E shot a 592 and a 590 = 1182
Athlete F shot a 591 and a 588 = 1179
Athlete G shot a 590 and a 587 = 1177
Athlete H shot a 588 and a 585 = 1173

In the USA Shooting carry-the-qualification-score Final, Athlete A would retain a 1-point lead over Athlete B going into the Final; Athlete C will have to make up 4 points in the Final to catch Athlete A.

The first stage of the Final includes two 5-shot series. In this example, the athletes shoot the following shots:

Athlete B has made up 1.1 points on Athlete A so far and now leads Athlete A by 0.1 points. Athlete C, who is struggling a bit, has lost the lead over Athlete D.

The Final then switches to pairs of single shots with eliminations after every two shots.
